SECTION A - SUPPLEMENTAL INFORMATION

The purpose of this modification is to:

1. Update Section J Attachment 4 Task Order Procedures

As a result of this modification Section J Attachment 4 - Task Order Procedures, Section (b) - Ordering Process is hereby revised to read as follows:

(b) Ordering Process

Authority. The Task Order Contracting Officer (TO KO) will provide each contract holder with a fair opportunity to be considered for each Task Order. Orders under this contract are subject to FAR subpart 16.505 (orders exceeding \$3,000 and up to \$150,000), supplemented with respect to orders on behalf of DoD for services exceeding \$150,000 by DFARS 216.505-70.

Each order for services exceeding \$150,000 shall be placed on a competitive basis in accordance with DFARS 216.505 unless the TO KO waives the requirement on the basis of a written determination, using the justification and approval format in FAR 6.302-1. This competition requirement applies to orders placed by non-DoD agencies on behalf of DoD. Competition requirements are met only if the TO KO

(1)Provides a notice of intent to purchase to all contractors under the contract, including a description of work to be performed and the basis upon which the selection will be made; and

(2)Affords all contractors responding to the notice a fair opportunity to submit an offer and to be fairly considered.

Waivers. Waivers that can be considered are:

(1)the customers need for services is of such urgency that providing such opportunity would result in unacceptable delays;

(2)only one contractor is capable of providing services required at the level of quality required because the services ordered are unique or highly specialized;

(3)the order must be issued on a sole-source basis in the interest of economy and efficiency as a logical follow-on to an order already issued under the contract, provided that all awardees were given a fair opportunity to be considered for the original order;

(4)it is necessary to place an order to satisfy a minimum guarantee; or

(5)a statute expressly authorizes or requires that the purchase be made from a specified source (only applicable if services exceed \$150,000).

2. Provide the following clarification on T&M and FFP labor rates for SNVC, L.C. and its subcontractors:

The labor rates identified in Attachment 1 SNVC Master Labor Rate Table are the ceiling rates for SNVC and its originally proposed subcontractors. Should SNVC desire to subcontract with any company not listed in the Master Labor Rate Table (Attachment 1), the proposed labor rate(s) for the new subcontractor shall be equal to or lower than the corresponding labor rate(s) in Attachment 8 - SNVC Schedule B for the labor category and performance site proposed.

All other terms and conditions remain unchanged.
