BAE Systems Information Solutions Inc. (Contractor), a corporation duly organized and existing under the laws of the State of Virginia, and the United States of America (Government), enter into this Agreement as of December 31, 2009.

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers of the United States, has entered into certain contracts and purchase orders with BAE Systems Information Technology Inc. as shown in the attached list marked "Exhibit A" and incorporated in this Agreement by reference. The term "the contracts," as used in this Agreement, means the above contracts and purchase orders and all other contracts and purchase orders, including all modifications, made by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts and purchase orders).

(b) In consideration of these facts, the parties agree that—


