

The purpose of this modification is:

1. To extend the Ordering Period by thirty-six months, from 14 April 2015 through 13 April 2018, pursuant to FAR 6.302-1(a)(2)(iii)(A) and FAR 6.302-1(a)(2)(iii)(B). As a result, CLIN numbers will continue to follow the 9XXX series.
2. Per ITES-2S Extension Letter signed by Pragmatics on 11 March 2015, the extension of the Ordering Period will not result in any changes to its Labor Rates Table, therefore resulting in a no-cost modification.
3. This extension of the Ordering Period is intended to bridge the ability to purchase services until the Information Technology Enterprise Solution - 3 Services (ITES-3S) suite of contracts is awarded. After the completion of a phase-in period for the ITES-3S contract (which may take up to 60 days, but could be less), the Government will cease placing new orders under this contract. The Government will advise all contractors of its intended cut-off date for new Task Order competitions under the extended Ordering Period.
