ADDENDUM TO FAR 52.212-4, CONTRACT TERMS AND CONDITIONS - COMMERCIAL ITEMS (May 2015)

The purpose of modification P00037 to contract W91QUZ-06-D-0002 is as follows:

1. Pursuant to FAR 6.302-1(a)(2)(ii)(B), extend the Ordering Period from 24 April 2016 up to 23 October 2017. The Period of Performance is outlined as:

Base Extension (6-month base): 24 April 2016 - 23 October 2016

Option 1 (6-month option): 24 October 2016 - 23 April 2017

Option 2 (3-month option): 24 April 2017 - 23 July 2017

Option 3 (3-month option): 24 July - 23 October 2017

2. Increase the ceiling by \$675,000,000.00 from \$5,000,000,000.00 to \$5,675,000,000.00.

3. Per Dell's email dated 23 Feb 2016, the extension of the Ordering Period and increase in ceiling will not result in any changes to its terms and conditions. In addition, the extension of the Ordering Period and increase in the ceiling will not cause any changes to its price schedule, therefore resulting in a no cost modification.

4. This extension of the Ordering Period is intended to bridge the Army's ability to purchase hardware until the Army Desktop and Mobile Computing 3 (ADMC-3) suite of contracts is awarded. The Government will advise all contractors of its intended cut-off date for new Delivery Order competitions under the extended Ordering Period IAW DFARS 252.216-7006.

6. Revised ADMC-2 Contract Management Deliverables_23Mar2016_final is hereby attached and incorporated into this modification. This revised document is identified as Attachment 0002 to this modification. The mandate for use of the new Order Transaction (OT) Report template shall start with the 10 MAY 2016 reporting cycle.

7. ACC-RI Government Point of Contact List is hereby incorporated into this modification as Attachment 0003.

8. All other terms and conditions remain in full force and effect as incorporated into the contract.

(a) This is an indefinite-quantity contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the maximum. The Government shall order at least the quantity of supplies or services designated in the Schedule as the minimum.

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contracts effective period; provided, that the Contractor shall not be required to make any deliveries under this contract 180 days after contract expiration.

(a) The Government may extend the term of this contract by written notice to the Contractor within 30 days; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 18 months.

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the contract schedule. Such orders may be issued from 24 April 2016 through 23 October 2017, if all options are exercised.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c)(1) If issued electronically, the order is considered "issued" when a copy has been posted to the Electronic Document Access system, and notice has been sent to the Contractor.

(2) If mailed or transmitted by facsimile, a delivery order or task order is considered "issued" when the Government deposits the order in the mail or transmits by facsimile. Mailing includes transmittal by U.S. mail or private delivery services.

(3) Orders may be issued orally only if authorized in the schedule.
